From the President

First I want to thank Guy Woo for taking on, temporarily, editing and production of our newsletter. He is our treasurer and good treasurers must be treasured, not burnt out. A nomination or volunteer for the position of newsletter editor is very urgently required. Please get in touch with Guy directly.

The Windsor Park Community League Annual General Meeting is scheduled this year for November 7. If we had had it on our traditional last Friday in October we would have been competing with the ghosties, goblins, and ghoulies of Halloween. Please make it a point to come and even better to pitch in on the executive. The membership canvassers are out in force. Windsor Park has always had a good community league membership and particularly this year it is important that the executive be again able to point to membership statistics to demonstrate that we truly represent the community. Be kind to your canvasser when he or she calls.

The main issue that presently faces the community is VOCO Development's proposal to build a 6 storey condominium on the shopping center site just east of the old Esso Service Station Site. You can find details on the community league web site, but I want to use this space to focus the discussion a little.

In two meetings the community has very clearly stated that they unanimously oppose any kind of rezoning. The

condominium project cannot go ahead if rezoning is refused. The unanimity is very helpful in presenting the case, but there are implications to this position. It is currently conventional wisdom that neighborhood commercial projects cannot make money. This comes not only from VOCO, but also from others with whom I've discussed the issue. "Everyone hops in their car and runs to the big box stores." Whether or not it accurately reflects our neighborhood, that view is prevalent in City Planning and on city council.

It follows that in order to carry the Windsor Park argument successfully we need good evidence that the site is not like others and that there are uses that fit into the community and that stand a reasonable chance of being profitable. Send your input on this subject to [John Wilson](#) directly please.

Even if we do find uses for the site, we need to find a developer willing to work for a modest, not an exorbitant profit. In Edmonton that may not be easy.

Since Mr. Wu has indicated to me that he is going ahead with the rezoning application, members of the community might usefully do a few things. Now as the opportunity presents itself, but certainly as soon as the VOCO application is filed:

1. If you know someone who lives in or near University Place in Garneau, another of VOCO's developments, ask them about their experience with VOCO.

2. Please explain to all councilors, not just Phair and Batty, why the community opposes this application. Such communication should be direct, not filtered through the community league or related organizations. Person to person, or snail mail has more impact than e-mail, but e-mail will not be ignored.

3. Be prepared to be present at a council hearing on the rezoning.

Councilors are very aware of voters who take the trouble to come to meetings.

4. Come up with creative uses for the site if it remains zoned as CNC or similar

We are building the counter case for when the matter reaches City Council. I don't intend to make that public until the time comes.

Staying Sharp as a Whistle

Having trouble remembering where your keys are, or the name of the person you just met? To a certain point, that's natural and nothing to worry about; we all gradually lose brain cells. But the older we get, the more likely these changes can affect memory. In fact, for every one Alzheimer's patient, it is estimated that eight seniors have memory loss severe enough to harm their quality of life.

Here are some steps you can take to keep your memory sharp with the passage of time:

- exercise regularly, as this improves blood and oxygen flow to the brain
- eat plenty of fruits and vegetables, which are rich in antioxidants that nourish brain cells
- quit smoking, which causes blood vessel constriction and can reduce blood flow to the brain
- drink plenty of water to prevent dehydration, which can lead to tiredness and interfere with concentration
- reduce stress and get a good night's sleep
- read or try a new hobby; the brain is like a muscle and remains strong when you exercise it

The use of certain medications, poor vision and/or hearing, vitamin deficiencies, diabetes and depression can all contribute to memory problems. Talk to your doctor or pharmacist to determine if one of these factors could be impairing your memory.

The Windsor Park Parking Program

The Windsor Park Parking Program reminds all residents that your new UA4 residential parking permits, and Visitor Passes for 2003-2004, should have been mailed to you. The old permits and passes expire as of September 30, 2003. Please pay careful attention to the conditions of use of Visitor Parking passes. They are NOT to be used for student or staff parking while attending University. Such abuse of the passes may result in loss of not only the current year's pass, but next year's as well. Please remind all members of your household that these passes are only to be used by visitors to your residence.

The City of Edmonton has been very helpful in enforcing residential parking restrictions during the first few weeks of University. If you witness a parking violation (such as parking without a permit or pass), call the Police Non-emergency complaint line at 423-4567, and ask to speak to Bylaw in order to have a Parking Patrol bylaw officer dispatched.

Complaints have been received about back alley congestion due to vehicles parking along fences and behind garages, etc. If the vehicle is encroaching on the alley proper, bylaw may be called for assessment re ticketing. Please be considerate of your neighbours before agreeing to alley parking arrangements. Residents must have a business license in order to rent

parking spaces, and this is unlikely to be granted in this residential area. Other neighbourhoods, near the Commonwealth Stadium, have had success in stopping this practice, and it may be time for Windsor Park to tackle this issue more aggressively.

Zoning Information

Windsor Park residents may be interested in specific information on CNC and DC-2 zoning given the motion passed in support of retaining CNC zoning for the parcel of land on 87th Avenue west of 117 St. and east of the former Esso site as well as the proposal to rezone to DC-2 for the purpose of building a 6-storey condominium.

CNC zoning permits structures 10 metres, 2.5 storeys in height. The following table presents the types of uses that can occupy CNC areas. Permitted uses, listed on the left, are the types of businesses that have a right to operate regardless of community concerns or views. These uses cannot be appealed. Discretionary uses, listed on the right, require notification of neighbours and the community league, and can be appealed if the community has concerns.

Permitted Uses	Discretionary Uses

DC-2 zoning is for site-specific development. It is used when the development exceeds the provisions of the closest equivalent conventional zone or has unique characteristics. This zone is supposed to minimize conflicts with neighbouring properties. An application for DC zoning must include:

- an explanation justifying DC zoning
- documentation that the community was informed of the proposed development and had opportunity for input
- comments from the community
- changes to the application in response to community input and concerns.

No individual is eligible to work in a casino if convicted, within the last five years, of a criminal offence related to narcotics, or to acts of dishonesty, including but not limited to, offences involving fraud, currency, or gaming and betting or those against the rights of property (such as theft, robbery, forgery), or fire arms and offensive weapons, or an indictable offence for an act of violence against a person. If five years after conviction, an individual is still under sentence for such an offence, registration shall not be approved until completion of sentence. AGLC may contact police for relevant information about the applicant. If an individual has received a pardon under provisions of the Criminal Records Act, this policy will not apply.								
Paid staff of the licensed organization can work, provided:								
a. They are members of the organization as defined by their bylaws;								
b. They volunteer their services outside normal working hours;								
c. They do not fill the following positions: General Manager, Alternate General Manager, Banker, Count Room Supervisor;								
d. No individual shall work more than one position during the licence period of the casino;								
e. All personnel shall be eighteen (18) years of age or older.								
I certify that the information in this application and any attachments are true, correct and complete to the best of my knowledge and belief. I understand that any false statement made in this application and any attachments may disqualify me from working at a casino.								
I hereby consent to and authorize the AGLC to undertake a criminal record check, with any police agency, to determine my eligibility to be involved in gaming facilities, in accordance with the Commission policies. An applicant may also be required to obtain and provide a criminal record check from a police agency.
